- providing management systems to ensure that the OH&S Policy is put into action.
- organizing, implementing, monitoring, auditing and reviewing of these systems to ensure that the OH&S standards are maintained at all times.
- conducting and acting upon risk assessments in all areas of the business to eliminate where possible or minimise and or reduce OH&S hazards and risks.
- eliminating injuries and occupational ill health to workers, contractors, visitors, temporary- workers, any
 other interested parties and any members of the public who might be affected by Telehouse operations.
 By conducting our operations in a safe manner by all and accepting that no one should come to work to get
 hurt and protecting their wellness and wellbeing.
- developing a culture where all workers, contractors, visitors, temporary workers, any other interested parties and members of the public take ownership for creating and maintaining a safe working environment.
- objectives are set and reviewed annually to ensure Occupational Health & Safety is core to our business operations and achieved in a timely manner.
- providing finances and resources reasonable to implement this policy statement.
- consultation and participation of its workers.

Each Director, Head of Department and Manager is expected to ensure their operations fully comply and follow all legal and other requirements, this policy statement, all risk assessments, procedures and safe systems of work.

Every worker will be given information, instruction and training necessary to enable safe working.

It is a legal duty of every worker, contractor, visitor, temporary-worker, any other interested party and member of the public to take reasonable care for their own Health & Safety and for others who may be affected by their activities whilst on Telehouse premises. This policy statement must be adhered to at all times. All significant work-related injuries, incidents, accidents, hazards and near misses will be reported, recorded and investigated, where root cause and corrective actions are highlighted for addressing to stop reoccurrence.

Working safely is a condition of employment and whilst on Telehouse premises.

It is the responsibility of ALL members of staff to abide by this policy.

Non-compliance with this Policy may lead to action under TIE's disciplinary process.
